Payment Terms

- 1 For the initial 3 months* on becoming a customer of The Spice Trader Ltd, payment for all orders must be made prior to dispatch of goods.
* or 3 orders, if frequency is less than monthly
- 2 For the 4th month and thereafter, payment of invoices must be made by you by the 20th day of the month following the date of invoice, in full, without deduction, set-off, or counterclaim.

On payment of the invoice for the 4th month or order (by the due date), as a new customer we will ship to you free of charge spice products to the equivalent value of 20% of the total value of your first 3 orders. This is a great deal for new customers and will help to ensure a good business relationship between The Spice Trader Ltd and our customers.
- 3 Failure to pay 2 consecutive month's invoices from The Spice Trader Ltd by the due date (i.e. by the 20th of the month following the invoice), will result in cancellation of credit account terms and payment for further orders will be required prior to the dispatch of goods.
- 4 All goods remain the property of The Spice Trader Ltd until paid for in full.
- 5 Without in any way limiting our right to require payment in full on the due date, if you default on the due date, all moneys owing to us shall immediately become due and payable and we shall be entitled to charge interest on such outstanding amounts at the rate of 3% per annum above the current base lending rate charged by our bankers, on a daily basis from the date payment is due until the date when payment is made.
- 6 You will be liable to pay all collection charges, expenses and legal costs (calculated on a solicitor/client basis) incurred by us in relation to, and to obtain remedy of, such failure to pay.
